CALL TO ORDER

Dan Dronberger called to order the March 20, 2017, ESD Board starting at 5:00 p.m.

MINUTES

Dan Dronberger asked if there were any additions or corrections to the minutes from the February 20, 2017 board meeting. Dan Dronberger made a motion to accept the minutes as written. Mike Jones seconded the motion with unanimous approval of the board.

PUBLIC COMMENTS

No public in attendance.

FINANCIAL REPORT

Dan Dronberger handed out the comparison of February 2017, Profit and Loss Statement versus our 2017 Budget. Not a lot of activity in the month of February. Minor changes to miscellaneous revenue. Dan Langford – Sales Tax Assurance has a significant increase. FCW – not understanding the big month of income, we contacted Sales Tax Assurance. The increase was because of Republic Services owing \$29,000.00 in taxes.

Dan Dronberger reported on the bank balances in our various accounts as of February 28, 2017.

Checking Account: We had a beginning balance of \$1,335,577.64 with deposits totaling \$1,310,184.51 (which includes an interest deposit of \$828.07); and checks and debits totaling \$184,759.47, for an ending balance of \$2,461,002.68.

Money Market Account: We started with a beginning balance of \$413,256.13 with an interest deposit of \$63.40, for an ending balance of \$413,319.53.

Sales Tax Money Market Account: Beginning balance of \$991,486.91 with deposits totaling \$159,372.75 (which includes an interest deposit of \$164.33), for an ending balance of \$1,150,859.66.

Dan Dronberger asked if there were any questions concerning financials. No questions.

Mike Jones made a motion to approve the financials and pay the bills as presented. Shirley Jauma seconded the motion with unanimous approval of the board.

FIRE CHIEF REPORT

Fire Responses

We had 138 responses in February.

One fire on Mathis Church Road storage facility. Mutual aid called quickly. Originating call from Motel on Rolling Creek.

PVFA Board Position Opening

PVFA has two board positions open. Dan Vogel has retired and Paul Nichols has moved to Marble Falls, Texas. Please advise if you know of anyone who may be interested in joining the PVFA Board.

Gillman Subaru Donation

FCW – Gillman Subaru donated \$10,000.00 to outfit station 63 with furnishings. To date we have purchased a television, sound bar with wall mount and lounge chairs. Total spent \$8,400.00. When we are finished purchasing we will send him an invoice and he will reimburse the PVFA. We have also ordered 11 beds including mattresses and frames. The beds ordered from Beds to Go on FM1960.

Station 63 Dedication

Sunday, April 23, 2017 is the dedication for Station 63 at 1:00 pm.

We have ordered medallion coasters as gifts with a line drawing of New Station 63.

Annual Crawfish Boil

Scheduled for May 14, 2017, at Station 63 at 2:00 pm.

Station 62 Staffing

We are using Engine 62 and one of our staff members. Spring Fire Department continues staffing at Station 62.

Purchase of 3 Replacement Fire Engines

Dates for the preconstruction meeting at Pierce Manufacturing for the new fire trucks will be available soon.

Camper 63

Camper 63 was involved in an accident and totaled. PVFA board approved last week the purchase of a replacement camper for \$8,600.00.

1972 Fire Engine

Old fire truck currently in renovation with Non-ESD funds. Rehab Garage is moving their business location to Tomball, Texas.

Washer & Dryer Extractor

Because of the late receipt of the washer and dryer invoice our auditors suggested we use 2017 budget funds, although it is was 2016 budget expense item.

Station 63 Construction

Tony Spitzenberger – we are making headway and about 90% complete. Waiting for confirmation on the windows and the estimated delivery date.

Started finals on the building counters and millwork at the station. Plumbers are installing fixtures. Once the windows are in, they can do the final painting and then polishing the floors.

The door company was at Station 63 today and doors should be operational tomorrow. Landscaping is done, we used Bermuda grass, it stronger and more durable.

Asphalt and addendum to contract to fix the black top at Station 63. We asked Lynn Foster to have the contractor meet us on site, after reviewing the surface, it does not need replacing. Our cost is \$25,000.00 to repair the black top surface. We have money in the contingency fund left to pay the interest on the \$25,000.00, or we could pay it out of pocket. Should we proceed? The asphalt is starting to deteriorate, so we need board approval to move forward.

Mike Jones made a motion to pay for asphalt with ESD Funds and not the construction contingency fund. Dan Dronberger seconded the motion with unanimous approval of the board.

New Commissioner Position for Shirley Jauma

Discussion held by the board members concerning Shirley Jauma's position within ESD#28 Board. After discussion, Shirley Jauma will become the appointed Secretary of ESD#28 Board.

Mike Jones made a motion for Shirley Jauma to hold the Secretary Position of ESD#28. Dan Dronberger seconded the motion with unanimous approval of the board.

Municipal Information Services

Ron Welch – distributed the Harris County Emergency Services District #28, Update to Comprehensive Review package, to all board members.

Taxable Value in the ESD

According to the Harris County Appraisal District as of December 23 2016, the 2015 certified taxable value of real and personal property located within the ESD was almost \$2.71 billion. At that time, only \$27,224 of the 2015 levy was uncertified. The 2015 total taxable value was approximately \$178.07 million more that the taxable value in the ESD for the 2014 tax year.

Also, as of December 23, 2016 the certified taxable value of the 2016 tax year was over 2.98 billion.

Tax Revenues of the ESD

Based on the 2016 Tax roll levy the ESD currently is in process of receiving approximately \$2.85 million.

Population within ESD

Approximately 48,146 persons in 2016 respectively.
