Ken Koenig reviewed report on sources and uses of cash for the month of August 2019 with the board.

Bank balances in our various accounts as of August 31, 2019:

Checking Account: We had a beginning balance of \$6,190.47 with deposits totaling \$350,982.87 (which includes an interest deposit of \$12.03); and checks and debits totaling \$344,526.14, for an ending balance of \$12,647.20.

Money Market Account: We started with a beginning balance of \$15,224.05, with an interest deposit of \$5.76, and checks and debits totaling \$224.05, for an ending balance of \$15,005.76.

Sales Tax Money Market Account: Beginning balance of \$250,233.66, with deposits totaling \$168,366.41 (which includes an interest deposit of \$238.71), and checks and debits totaling \$168,361.36, for an ending balance of \$250,238.71.

Texas CLASS Account: Beginning balance of \$4,223,679.85, with deposits totaling \$176,964.59 (which includes an interest deposit of \$8,379.18), for an ending balance of \$4,400,644.44.
