

# Notice of Public Hearing on Tax Increase

A tax rate of \$0.10 per \$100 valuation has been proposed by the governing body of **Harris County Emergency Services District No. 28**.

PROPOSED TAX RATE	\$0.100000 per \$100
NO-NEW-REVENUE TAX RATE	\$0.084813 per \$100
VOTER-APPROVAL TAX RATE	\$0.087953 per \$100
DE MINIMIS RATE	\$0.096063 per \$100

The no-new-revenue tax rate is the tax rate for the 2022 tax year that will raise the same amount of property tax revenue for **Harris County Emergency Services District No. 28** from the same properties in both the 2021 tax year and the 2022 tax year.

The voter-approval rate is the highest tax rate that **Harris County Emergency Services District No. 28** may adopt without holding an election to seek voter approval of the rate, unless the de minimis rate for **Harris County Emergency Services District No. 28** exceeds the voter-approval rate for **Harris County Emergency Services District No. 28**.

The de minimis rate is the rate equal to the sum of the no-new-revenue maintenance and operations rate for **Harris County Emergency Services District No. 28**, the rate that will raise \$500,000, and the current debt rate for **Harris County Emergency Services District No. 28**.

The proposed tax rate is greater than the no-new-revenue tax rate. This means that **Harris County Emergency Services District No. 28** is proposing to increase property taxes for the 2022 tax year.

The proposed tax rate is also greater than the voter-approval tax rate and the de minimis rate. If **Harris County Emergency Services District No. 28** adopts the proposed tax rate, **Harris County Emergency Services District No. 28** is required to hold an election so that the voters may accept or reject the proposed rate. If a majority of the voters reject the proposed tax rate, the tax rate of the **Harris County Emergency Services District No. 28** will be the voter-approval rate of the **Harris County Emergency Services District No. 28**.

A **PUBLIC HEARING ON THE PROPOSED TAX RATE WILL BE HELD ON August 23, 2022 at 5:30 p.m. at Station #61, 17061 Rolling Creek Drive, Houston, TX 77090.**

**Harris County Emergency Services District No. 28** may take action on the proposed tax rate on August 23, 2022 at 5:30 p.m., following the hearing to be held.

The election will be on November 8, 2022. You may contact the Harris County Clerk's Office – Election Department for information about voting locations. The hours of voting on election day are 7:00 a.m. to 7:00 p.m.

YOUR TAXES OWED UNDER ANY OF THE TAX RATES  
MENTIONED ABOVE CAN BE CALCULATED AS FOLLOWS:

$$\text{Property tax amount} = (\text{tax rate}) \times (\text{taxable value of your property}) / 100$$

The 86<sup>th</sup> Legislature modified the manner in which the voter-approval tax rate is calculated to limit the rate of growth of property taxes in the state.
