### Call to order, roll call and establishment of a quorum.

Mike Jenkins called to order the October 17, 2022, ESD No. 28 Board Meeting starting at 5:00 p.m., with a quorum.

### To approve the Minutes of prior meeting.

Mike Jenkins asked if there were any additions or corrections to the minutes from the September 19, 2022, Regular Meeting minutes.
