

NOTICE OF PUBLIC MEETING
HARRIS COUNTY EMERGENCY SERVICES DISTRICT NO. 28

Notice is hereby given that Harris County Emergency Services District No. 28 will hold a public meeting on July 20, 2026, at 5:00 p.m., at 17061 Rolling Creek Drive, Houston, TX 77090.

The District will consider and act upon the following matters:

1. Call meeting to order, roll call and establish a quorum.
2. To receive public comments.
3. To approve the Minutes of prior meeting(s).
4. To review, discuss and propose the District's 2027 Budget.
This is an item to begin the Budget adoption process for the upcoming FY 2027. The District acknowledges the requirement of Government Code §551.043(c)(2) to prepare a taxpayer impact statement when reviewing and adopting budgets. However, certified values are not yet available and the required no new revenue tax rate calculations are not yet available. Therefore, no Taxpayer Impact Statement is included.
5. To review, discuss and propose the District's 2026 Tax Rate.
6. To schedule a public hearing regarding the District's 2026 tax rate and the date of the meeting to adopt.
7. To review and take action on matters relating to an election to be held on November 3, 2026:
 - Approve an Order of Election under Texas Tax Code Section 26.07.
 - To review and take action to hold an election jointly with other jurisdictions.
 - To review and take action to contract with Harris County Elections Office for election services.
 - To consider and take action on such other Orders, Resolutions and related matters as required or appropriate to call for the District election
8. To receive a Financial Report from the District Treasurer and to pay District bills, including approval of commissioner's fees.
9. To review and take action on the payment of operations funding pursuant to year 2026 budget and service agreement with the Ponderosa Volunteer Fire Association, Inc.

10. To receive a report from the Ponderosa Fire Department (“Department”).
11. To review, discuss and take action regarding the purchase of capital equipment including apparatus.
12. To review, discuss and take action regarding Care’s Act-Employee Retention Tax Credit Refund.
13. To review and discuss district newsletter.
14. To review and discuss matters related to Texas Emergency Communications Center, to include shared construction costs and payments related to the construction of a new dispatch center.
15. To review, discuss and take action regarding Regional Radio Grant.
16. To meet in Closed Session pursuant to Government Code §551.071 to consult with legal counsel.
17. To meet in Closed Session pursuant to Government Code §551.072 to deliberate regarding real estate matters.
18. To set meeting dates for August 17, 2026, Regular Meeting at 5:00 pm, in the conference room at Station 61, 17061 Rolling Creek Drive, Houston, TX 77090.
